Re: NEW CCX FEE SCHEDULE

Effective September 15, 2008, the following changes in transaction fees will apply.

- Fees for Block Trades will increase for the buyer from \$5.00 to \$25.00.
- Fees for the “buy-side” of cash transactions where the buyer of the cash transaction has access to the CCX Trading Platform will increase from \$5.00 to \$25.00 per CFI.

The attached schedule summarizes the new fees for the Chicago Climate Exchange (“CCX”). Transaction fees are quoted per Carbon Financial Instrument (“CFI”), which represents 100 metric tons CO₂.

These rates have been established by the CCX Executive Committee pursuant to CCX Rule 2.8. - Fees and Payments.

Sub account maintenance fee (to be assessed upon the creation of each sub account and annually on January 1st thereafter)	\$250 per account

Notes

1. All trading platform fees are due on T+1 and will be added or deducted from trade settlement proceeds.
2. Eligible trades are defined as follows:
 - Day Trade is defined as offsetting buy and sell transactions for the same account in the same vintage during the same trading session
 - Break-Even Day Trade (also known as a "scratch" trade) is defined as a Day Trade occurring at the same price.
 - Spread Trade is defined as an offsetting buy and sell transaction for the same account in different vintages during the same trading sessionEach leg of the above trades must be executed on the trading platform to be eligible. One or both legs executed as block trades do not apply.

All fees are subject to change by CCX. CCX will notify the membership of all fee changes via CCX advisories. All advisories can be found on the CCX website at www.chicagoclimateexchange.com

3. Issuance fees for forest carbon stock allowances are for Phase II vintages only.
4. Offset registration and deregistration fees and fees for early action credits will be based on the geographic location of the project (Annex I and non-Annex I countries).
